

**Town of Angier Board of Commissioners'
Special-Called Meeting
Minutes
Tuesday, February 9, 2016, 6 p.m.
Angier Municipal Building**

The Town of Angier Board of Commissioners convened during a Special-Called meeting Tuesday, February 9, 2016, in the Board Room inside the Municipal Building at 28 North Raleigh Street. The primary reason for the meeting was to interview four candidates who had applied for the vacant Ward 1 Commissioners' post left vacant by current Mayor Weatherspoon.

2. Mayor Weatherspoon presided, calling the Board of Commissioners' Special-Called meeting to order at 6:00 p.m. and leading the pledge of allegiance.
3. Commissioner McKoy offered the invocation.
4. **Approval of the February 9, 2016, meeting agenda:** The Board of Commissioners approved the agenda as presented to them, making no modifications.

Vote: Unanimous, 3~0


5. **Question and Answer Session with all four (4) Candidates: (The 30-minute sessions were scheduled in alphabetical order).** The applicants – Larry Alexander, Brian Ennis, Brian Hawley and Jerry Hockaday – were interviewed during an open session in 30-minute intervals beginning at 6 p.m. After a five-minute introduction, members of the Town Board asked each candidate 10 questions, followed by the applicants' five-minute summarization.



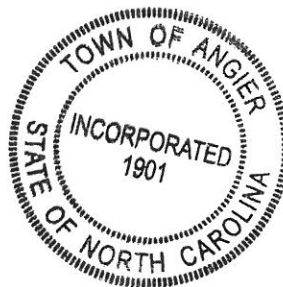
The vote tabulation was certified by the Town Clerk, Kim Lambert, and given to Mayor Weatherspoon who made the announcement before the Board and audience members.
