- 7. Brian Hawley, Board Chairman opened the floor for an update regarding the Angier ABC Store's merchant services. Christina Kazakavage, Finance Officer stated that Scott Chappell with Atlantic Merchant and Steve Gaskins with Steve Gaskins Consulting are coordinating on the install.
- 8. Board Chairman, Brian Hawley opened the floor for discussion on the Angier ABC Drug & Alcohol Policy. Shawna Mason, Assistant General Manager stated that all employees have signed the policy acknowledgement. Uncommon Care can do the testing for \$60/each. George Price, Board Member suggested looking into I-Cup urine drug screening. This will be discussed again at the next meeting with I-Cup information provided.
- 9. Brian Hawley, Board Chairman opened the floor for an update regarding the Angier ABC Store's phone and internet services. Christina Kazakavage, Finance Officer stated that we are working with Spectrum to get the email up and running. The fax line has successfully been disconnected. Centurylink has not been disconnected until the email is complete and all machines are working adequately.
- 10. Board Chairman, Brian Hawley opened the floor for discussion of adding "Store Funds" to the Bank Deposit policy. The Board is going to look into creating a policy regarding the transportation of store funds.
- 11. Brian Hawley, Board Chairman has opened the floor for discussion of the dumpster gate. The Board was provided two quotes. After lengthy discussion over the quotes, materials being used/not used, Board Chairman Hawley suggested tabling until pricing for alternative material trex can be established.
- 12. Board Chairman, Brian Hawley opened the floor for discussion regarding grounds maintenance for the Angier ABC Store. It was asked if Board Member Jerry Hockaday's son, Chris Hockaday would be interested in taking over the grounds maintenance for the Angier ABC Store.
