### **Pre-Retreat Tasks**

#### Task 1.0 -- Prepare Growth Audit

- Conduct research on growth and development in Angier, and the current systems the Town uses to guide growth decisions.
- Take a guided tour of the town with the Planning Director.
- Talk with developers and key stakeholders in the community (up to 6 online interviews of 30- to 60-minutes each)
- Talk with staff at other key agencies such as Harnett County and CAMPO
- Analyze policies on existing conditions, plans, codes, infrastructure, staff capacity, and funding.

#### Task 2.0 -- Prepare Presentation

- Prepare summary presentation that lays out the major growth issues, opportunities, and potential issues that should be examined.
- Review draft of presentation with Town Manager and Planning Director.
- Revise presentation based on input received.
