Section 7: All fees appearing on the Fiscal Year 2019 - 2020 Rate and Fee Schedule as set forth in Attachment A shall be adopted by the Board and is to be in effect during the Fiscal Year 2019-2020 and is on record in the Clerk's office.

Section 8: The Town Manager, or his or her designee, is hereby authorized to transfer appropriations within a fund as contained herein under the following conditions:

- A. He may, at his option, divide the appropriations into revenue and expenditure objects for the purpose of managing the finances of the Town at the object level. Authorization to move budgetary amounts within these revenue and expenditure objects is hereby granted.
- B. He may transfer amounts between line item expenditures within a department without limitation with an official report on such transfers at the next regular meeting of the Town Board as in accordance with G.S. 159-15. These changes should not result in changes in recurring obligations such as salaries.
- C. He shall be authorized to make interfund loans for a period of not more than ninety (90) days; notification of such loan shall be given to the Town Board of Commissioners at its next meeting following the date of the loan.

Interfund and interdepartmental transfers, except as noted in Section 8, Subsections A, B, and C shall be accomplished by the Town Board of Commissioners only.

Section 9: The following is the salary schedule for the Town of Angier's Board of Commissioners for the fiscal year beginning July 1, 2019 and ending June 30, 2020:

Section 10: The Town Board of Commissioners has retained the services of outside legal counsel at a monthly flat rate of \$3,750 to represent the Town in legal matters which extend beyond the normal boundaries of staff counsel.

Section 11: The Town Board of Commissioners has authorized in the Fiscal Year 2019-2020 Budget to include a Town contribution to the 401K Retirement Plan of 5% of a regular employee's salary. The Town shall contribute 5% of sworn law enforcement officer's salary, regardless of employee contribution as required by G.S. 143-166.50(e).

Section 12: The Board of Commissioners has authorized in the Fiscal Year 2019-2020 Budget to include the following cost sharing for group health insurance based on an employee's full time equivalency. At the time of this adoption, the following costs are estimates only. These figures will be adjusted when the Town receives the final costs from the insurance company.

Section 13: The Town Board of Commissioners has authorized the Fiscal Year 2019-2020 Salary Grade Table to include a 4% cost of living increase effective July 1, 2019 as set forth in Attachment B.

Section 14: The power of approval of contracts and authorizations of settlements for liability claims is hereby reserved by the Town Board of Commissioners.

Section 15: There is hereby levied a tax at the rate of fifty three cents (53¢) per one hundred dollars (\$100) valuation of property listed as ad valorem taxes as of January 1, 2019, for the purpose of raising revenue listed as 2019 Tax Revenue in the Town of Angier General Fund. The rate of tax, for the purpose of taxation, is based upon an estimated total valuation for Harnett County property of \$279,833,415, a projected levy of \$1,483,117 and for Wake County property of \$50,917,541, a projected levy of \$269,863 and an estimated collection rate of 99.83%.

Section 16: Operating funds encumbered by the Town as of June 30, 2019, are hereby appropriated to this budget.

Section 17: The Board of Commissioners of the Town of Angier hereby authorize, empower, and command the Harnett County Tax Administrator and the Wake County Tax Administrator to bill and collect taxes on the Town's behalf in accordance with the respective standing agreements.

Section 18: Reimbursement for use of privately owned vehicles by Town employees for official Town business will be made in accordance with the latest Standard Mileage Rate as set forth by the Internal Revenue Service. For the fiscal year beginning July 1, 2019 and ending June 30, 2020, mileage will be reimbursed at a rate of fifty eight cents (.58 cents) per mile.

Section 19: Copies of this Budget Ordinance shall be furnished to the Town Manager, Clerk to the Board and to the Finance Officer to be kept by them for their direction in the disbursement of funds.

Adjustment Policy:

Leak and break adjustments — all customers are allowed three (3) sewer adjustments in any one calendar year. You must provide the Town with a statement of repair from a plumber. In the event that the resident or landlord repairs the leak, a receipt showing the purchase of plumbing supplies and a statement from the individual who actually made the repair must be provided to the Town. **Hanging toilets are NOT eligible for adjustments**.

Delinquent Accounts:

Meters are read and bills are calculated on a monthly basis. Bills are mailed on the last working day of each month. Account balances are always due on the tenth (10th) day of the month. There is a grace period, which allows bills to be paid on the twentieth (20th) day of the month without a late fee. If balances are unpaid after 5:00pm on the 20th day of the month, or the Monday after (if the 20th falls on a weekend), a \$10.00 late fee will be applied on each account. If the balance has not been paid by 5:00pm on the 25th of the month or the Monday after (if the 25th falls on a weekend), the following late/disconnect fees apply:

1 st Late Fee/Disconnection	\$35.00
2 nd Late Fee/Disconnection	\$50.00
3 or more disconnections within a calendar year	\$75.00

Your account will final out after 10 days of disconnection if service has not been restored and your deposit (if applicable) will be applied to the balance on the account. If service is restored after the 10 day disconnection period, a new deposit (\$125.00) and connection fee (\$35.00) will be required. If service is disconnected and a meter shows any usage has occurred between the time of cut off and restoration, there will be a tampering fee assessed on the account in the amount of \$50.00. The tampering fee must be paid in addition to any other charges that may be due on the account before water service can be restored. The Town is not responsible for bills that are not delivered by the US Postal Service. If you do not receive your bill by the fifth (5th) of the month, you should contact Town Hall at (919) 639-2071 for your balance.

ISSUE Town Code Amendment – Trash Receptacles CONSIDERED:

DEPARTMENT: Planning & Inspections

SUMMARY OF ISSUE:

The Planning Department requests that the Board consider the adoption of Staff and Planning Board recommended amendments to Section 15-35 of the Town Code. These amendments intend to limit the number of refuse containers allowed on each property in Town. This amendment would coincide with the recently approved screening requirements for waste containers, thereby requiring all properties with excess refuse containers to replace them with a dumpster and then screen that dumpster.

Staff, the Planning Board and the Commissioners have discussed these Code amendments at several previous meetings. This amendment does not require a Public Hearing. Staff recommends the amendment be made effective approximately 6 months from approval so that enforcement coincides with the recently approved screening requirements.

FINANCIAL IMPACT:

Costs to add amendments to the Code will be paid out of the current Administration and/or Planning Department budget.

RECOMMENDATION:

Staff recommends the Board approve the amendments to Section 15-35 of the Town Code as presented, effective December 4, 2019.

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE II SECTION 15-35 OF THE TOWN OF ANGIER CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED by the Town of Commissioners' of the Town of Angier that Sec. 15-35 of Chapter 15 of the Code of Ordinances of the Town of Angier is amended as follows:

Sec. 15-35 - Placement, Removal of Containers; Duties of Occupants

Residential properties accounts will be provided up to two refuse containers and billed for each container requiring pickup on the monthly utility bill. Any number of refuse and recycle containers above two will require dumpster service at the owner's expense.

Commercial properties accounts will be provided up to three two refuse containers and two recycle containers. Any number of refuse and recycle containers above three will require dumpster service at the owner's expense.

- (1) Refuse containers shall be placed for collection at a location in such a manner as to be convenient for removal and collection.
- (2) It shall be the duty of the occupant of any building or any residential unit to:
 - a. Place the refuse container at a location in such a manner as to be convenient for removal and collection. The supervisor may require such placement at any location for reasons of topography, efficiency or emergency.
 - b. Remove the empty container from the place of deposit at curbside or otherwise to the storage location. Such removal shall be accomplished not later than 7:00 p.m. on the day of collection.
 - c. Empty garbage containers must be placed in a storage location behind or at the side rear of the dwelling or business.

SECTION XX Purpose of Chapter

The purpose of this chapter is to provide and define authority of the Harnett County Animal Services department within the towns of Angier, Coats, Erwin and Lillington. Harnett County Animal Services now has charge of protecting the citizens of these towns from rabies transmitted by unconfined, uncontrolled or Lin-immunized animals, to regulate animals that may be a nuisance, to insure that all animals are treated in a humane manner and in the promotion of responsible pet ownership and animal welfare. Harnett County Animal Services in cooperation with the towns of Angier, Coats, Erwin and Lillington are hereby charged with the responsibility of Animal Services in conjunction within these town's jurisdictions. This ordinance will supersede all town Animal Services ordinances and shall pertain to the towns of Angier, Erwin, Coats and Lillington only. The most current Harnett County Animal Services ordinance shall also pertain to the Towns in agreement of this ordinance.

SECTION XXI Establishment of Bird Sanctuary

- (A) The area embraced within the corporate limits of the Town and all land owned or leased by the Town outside the corporate limits is hereby designated as a bird sanctuary.
- (B) It shall be unlawful to intentionally trap, hunt, shoot, or otherwise kill, within a sanctuary hereby established, any native wild bird. It shall be lawful to trap birds or fowl specifically declared a nuisance by the Town board when such birds or fowl are found to be congregating in such number in a particular locality that they constitute a nuisance or a menace to health or property.
- (C) The bird clubs of the Town are hereby granted permission to erect artistic signs, giving notice of the regulations therein provided, at such places and of such design as may be approved by the Town Board.

State Law Reference: Bird Sanctuary establishment, G.S. 160A-188

SECTION XXII Hunting, Killing, and Trapping of Animals

It shall be unlawful for any person to hunt or kill any animal within the territorial limits of the Towns. Trapping may be done with permission from the Harnett County Animal Services Department. This section does not apply to the Police Departments or Harnett County Animal Services, or duly authorized agents when enforcing the provisions provided in this Ordinance.

SECTION XXLLL Keeping Livestock and Fowl

No person may keep within the Town any Livestock and/or Fowl except in accordance with this section.

- (A) It shall be unlawful for any person to maintain, keep, house or stable any:
 horse, mule, pony, cow, sheep, goat, swine or any other livestock including ducks,
 geese, turkeys, guineas within the corporate limits of the Town unless a permit has been
 issued for such use. Permits may only be issued for lots containing one acre or more and
 no livestock may be kept within 500 feet of any residential or commercial building,
 school grounds, church or other establishment.
- (B) It shall be unlawful for any person to maintain, keep or house any cattle, goat, horse, swine, ducks, geese, turkeys, guineas or any other Livestock on a fenced lot with in the corporate limits of Town unless a permit has been issued for such use. Permits may only be issued for lots containing one acre or more and no livestock may be kept within 500 feet of any residential or commercial building, school grounds, church or other establishment.
- (C) Any chickens kept within the corporate limits of the Town must be contained by a fence, building or other enclosure that will ensure that the chickens will not run at large.
- (D) Any Fowl found running at large may be taken into possession and/or destroyed by Harnett County Animal Services anywhere within the corporate limits of the town.

SECTION XXIV Number of Chickens

- (A) A maximum of six (6) hens (Gallus gallus domesticus) will be allowed per household.
- (B) NO <u>Roosters</u> or other poultry breeds will be permitted.
- (C) No free-ranging permitted. Hens must be kept in a chicken coop or enclosed runs at all times and are not permitted to roam freely on the Owner's lot.
- (D) The location of the coop and in closed run must be in the rear of the Owner's lot as determined by the line projected along the rear of the dwelling to each sideline and be 20 feet away from the adjoining Lots.
- (E) The coop and enclosed run must be a minimum often feet (10') in length and ten feet (10') in width and a maximum of sixteen feet (16') in length and sixteen feet (16') in width.
- (F) Coop design should provide ample ventilation to avoid odors and be made predator proof.

- (G) All manure and wood shavings from the coop must be disposed of properly by removing off-site by the owner or professional removal service.
- (H) Prior to beginning construction, a Land Use application shall be submitted and approved by the Zoning Administrator, for all coop and run designs.
- (1) The Code Enforcement officer, and its designees, has the right to enter onto the property for the purpose of inspecting the coop and run to ensure compliance with these requirements. The home owner will be notified no less than three days prior to the inspection date and has the right to be present during the inspection
- (J) Owners who are determined to be in violation may be allowed to correct the violation(s) and/or be subject to a fine, as per the Town's code. Daily penalties will be assessed in the event that the violation(s) continue. The Town may revoke this privilege if an Owner has had three (3) or more violations during one calendar year.

SECTION XXV Number of Dogs

It shall be unlawful for any person to keep on any lot or premises within the corporate limits more than three (3) dogs. This limitation shall not apply to dogs less than four (4) months of age. Any person wanting to keep more than three (3) dogs will apply to the Town for a license to operate a dog kennel. Prior to the issuing of such license it shall be determined that the kennel would be in compliance with all Town and State regulations.

SECTION XXVI Number of Cats

It shall be unlawful for any person to keep on any lot or premises within the corporate limits more than three (3) cats. This limitation shall not apply to cats less than four (4) months of age.

SECTION XXVII Confinement and Running at Large

- (A) No person owning or having possession, charge, custody or control of any animal may cause, permit or allow the animal to stray or in any manner to run at large upon any public street, sidewalk or other public property or to stray, run at large or otherwise trespass upon the private property of another.
- (B) It shall be unlawful for the owner of any animal to allow such animal to be at large on any Town property.

- (C) It shall be unlawful for any person owning, harboring, keeping or in charge of any animal to fail or refuse to remove feces deposited by the animal on any street, sidewalk, park or other publicly owned property.
- (D) It shall be unlawful for the owner of any animal to fail or refuse to remove feces deposited by the animal on any private property.

SECTION XXVIII Possession of Animals and Strays

- (A)I It shall be unlawful for any person in the town knowingly and intentionally, unless with consent of the owner, to harbor, feed and keep in their possession by confinement or otherwise allow to remain on their property any animal which does not belong to them unless they notify Harnett County Animal Services within forty-eight (48) hours from the time such animal came into his possession.
- (B) Any person who feeds a stray animal and/or allows the animal to stay on their property for at least two (2) days will be considered the legally responsible for such animal and any violations caused by the animal.
- (C) It shall be unlawful for any person to refuse to surrender any such stray animal to the Police Department or Harnett County Animal Services or person duly authorized upon demand.
- (D) The purpose of this section is to aid in rabies control and to prevent the intentional or unintentional possession of pets belonging to other persons.

SECTION XXIX Impoundment and Reclaiming of Captured Animals

- (A) Any animal within the Town without an owner, any animal running at large within the Town, or any animal whose owner fails to have the animal vaccinated in accordance with the laws of the State, or an animal appearing within the Town without a rabies vaccination tag shall be taken by Harnett County Animal Services and confined for a period of time until reclaimed by the owner with a pre-paid rabies voucher, adopted with a pre-paid rabies voucher or euthanized by the Harnett County Animal Services Department.
- (B) If any animal is not redeemed by the owner within three (3) days from the time Animal

Control takes possession of the animal, the animal shall be put up for adoption or disposed of under the regulations set forth by the Harnett County Animal Services Ordinance and the North Carolina General Statutes.

In order for the owner to redeem an animal, such owner must first show that the rabies vaccination tag has been procured. In addition the owner shall pay a penalty of fifty (50) dollars for allowing the animal to run at large. The fee may be adjusted in the new fiscal years in the Harnett County Animal Services fees. The owner must pay daily expenses for boarding and caring for the animal.

SECTION XXX Potentially Dangerous and Dangerous Dogs

- (A) It shall be unlawful for a citizen to keep a dog within the corporate limits of the Town a dog that has been deemed potentially dangerous or Dangerous by Harnett County Animal Services.
- (B) Any owner found in violation of this section will be required to release the dog to the Harnett County Animal Services Department for euthanasia and will face a civil fine of \$400.00.

SECTION XXXI Inherently Dangerous Exotic Animals

Shall be in accordance with the Harnett County Animal Services Ordinance

SECTION XXXII Enforcement, Penalties and Remedies

Enforcement Administration

Primary responsibility for enforcing the provisions of this chapter is assigned to the Harnett County Animal Services Department. Municipal Police Departments will assist when needed.

Penalties and Remedies

Penalties and remedies shall be in accordance with the Harnett County Animal Services Ordinance.

SECTION XXXIII Ordinance in Conflict

All ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

Ordinance Adoption


