SUMMARY OF ISSUE:

This budget amendment pertains to the Police Department. The Town of Angier will receive a grant in the amount of \$24,495.00 from the Governors Crime Commission (GCC), using the online tool, Grants Enterprise Management System (GEMS), which helps administer grants. The monies from this grant is to purchase replacement guns and ammunition.

FINANCIAL IMPACT:

This budget amendment will recognize the proceeds the Town will receive and will increase allowable spending within the Police Department. The General Fund will increase by \$24,495.00 to cover the purchases.
