Mayor Weatherspoon recommended that one resident's name be added to the Citizen Participation Plan ~ Rick Tudor. After adding Mr. Tudor's name for consideration, the Town Board voted on the proposed Steering Committee.

## 8. Manager's Report

Town Manager Price informed Town Board officials of numerous events that had taken place including:

- > There was to be no Planning Board nor a Board of Adjustment meeting in September.
- ➤ He announced the firm handling the Land Use Development Plan ~ Holland Consulting Planners, Inc., (HCP) of Wilmington.
- Mr. Price said meetings were being scheduled jointly with HCP, Transportation consultants from Mott MacDonald of Fuquay~Varina, and Economic Develop~ ment consultant, Ted Abernathy, from Economic Leadership. He said that the

- The Angier Chamber was to host its annual Crepe Myrtle Celebration Saturday, September 10, 2016.
- > The Angier Area Ministerial Association was to honor our local law enforcers during its first Unity in the Community event Saturday, September 24, 2016, from 10 to 11 AM at the Depot Square R.H. Ellington Grounds.
- ➤ The Harnett County Parks and Recreation Department was to sponsor a free Movie at Depot Square R.H. Ellington Grounds. The public was invited to see Disney's "The New Jungle Book Movie," Saturday, October 8, 2016, at 7 PM.
- ➢ He said this year's NC League of Municipalities' CityVision 2016 would be held October 22 ~ 25, 2016, in Raleigh. He said that EnviroLink had begun its study regarding a Water Rate Study, a Backflow Assembly and a Vacant Meter Policy.
- Mr. Price said Commissioner Jerry Hockaday had recently been honored at the Angier~Black River Fire Department, having his portrait commissioned as a former fire chief. Mr. Hockaday had served with the Angier~Black River Fire Department for 54 consecutive years.
- Mr. Hockaday announced that Roman Gabriel, III, founder of Sold Out, would be returning to Harnett County and would be facilitating meetings with students in the fall.
