- 1. Call to Order: Mayor Weatherspoon presided, calling the Board of Commissioners meeting to order at 8:04 a.m.
- 2. Pledge of Allegiance: Mayor Weatherspoon led the pledge of allegiance.
- 3. Invocation: Mayor Weatherspoon offered the invocation.
- **4. Approval of the September 12, 2018, meeting agenda:** The Town Board approved the agenda as presented.

Board Action: The Town Board unanimously approved the September 12, 2018 Emergency meeting agenda as presented.

Mayor Weatherspoon stated the purpose of the meeting is to allow the Mayor to declare a State of Emergency within the Town of Angier not only for the impending Hurricane but for future storms as well. He explained there is currently no mechanism in place for anyone to declare a State of Emergency.

Town Attorney Dan Hartzog Jr. explained the restrictions placed during an Emergency Declaration is optional. Restrictions can be placed specific to Angier such as curfews and he further explained that declaring a State of Emergency can also help with receiving relief funds.

Commissioner Smith suggested adding the verbiage under Section 3 of the Ordinance to read "a declaration authorized by this chapter shall be guilty of a misdemeanor, and punished as provided by Section 11-104 of the Town of Angier Code of Ordinances".

Board Action: The Town Board unanimously voted to approve the Emergency Declaration Ordinance with the above amendment.
